For hospitals, inadequate access to preventive care in underserved communities leads to more emergency department visits and hospitalizations for preventable conditions. 

Strategies to complete the assessment:

- > Gather stakeholders for a meeting. Schedule a 90-minute to 2-hour meeting with the key stakeholders to review each question and agree upon a response.
- > Divide up the questions. Assign each section of the assessment to a key stakeholder who is most likely able to answer the questions in that section. Allow them 3-5 business days to provide their responses.
- > Set up individual meetings with key stakeholders. Meet with key stakeholders, ask them the questions pertaining to their functional area, and record their responses.
